## CHANGES TO THE ANNISTON ROTARY CLUB BY-LAWS

Delinquent Account Policy,  
to be inserted as Section X, Article XX:

Each quarter the Anniston Rotary Club invoices members for club dues, lunch fees and optional payments for the Anniston Rotary Club Foundation and Rotary International Foundation. *Payment of the invoice is due upon receipt.*

Regarding delinquent accounts, the following procedures will apply:

- Members who have outstanding invoices will receive on their quarterly dues statement a detailed listing of all unpaid items.
- Members who have not paid their account in full by the end of 45

## Changes to By-Laws

*continued*

- days will be referred to the President and Treasurer. They will send a *Letter of Delinquent Account* to the member.
- Members receiving a *Letter of Delinquent Account* will have three weeks to bring the account current or establish a payment plan that will bring the account current in a reasonable time frame that is acceptable to the President and Treasurer.
  - Members who have received a *Letter of Delinquent Account* and have not brought their account current within three weeks or established an acceptable payment plan will be referred to the Board of Directors.
  - If any member is scheduled to receive a *Letter of Delinquent Account* and has belonged to the Club for less than three years, the Club member who proposed the delinquent member to the Club should be informed of the member's negligent status to see if any intervention is appropriate.
  - When a member is referred to the Board of Directors, after having received a *Letter of Delinquent Account*, and has not brought their account current or established an acceptable payment plan, the Board will make the determination as to whether or not to terminate membership — with the expectation that membership will be terminated without a compelling reason to do otherwise.
